## **ORDINANCE NO. 789**

## AN ORDINANCE OF THE CITY OF RIPON REZONING CERTAIN REAL PROPERTY IN THE CITY OF RIPON

WHEREAS, certain real property known as Assessor's Parcel Numbers; 245-340-35, 245-340-36, 245-340-38, 245-330-01, 245-330-02, and 245-330-13, owned by the City of Ripon, Central Valley Executive Builders, Inc. and Cornerstone Phase II, Inc., has been annexed to the City of Ripon; and

WHEREAS, the City Council has previously adopted the Ripon General Plan 2040, which designates the property for High Low Density Residential (HLD) and Medium Density Residential (MD); and

WHEREAS, the City Council has amended the Ripon General Plan 2040 Land Use Map to re-designate the property from High Low Density Residential (HLD) and Medium Density Residential (MD) to Park (P), Municipal Service - Fire Station (FS-MS) and High Low Density Residential (HLD); and

WHEREAS, the City Council, after conducting appropriate environmental analysis pursuant to CEQA, and after conducting duly noticed meetings and hearings desires to rezone the property for uses which are consistent with the adopted General Plan Land Use Map designations for the property.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Ripon as follows:

<u>Section 1</u>: The City of Ripon hereby amends the Zoning Map of the City of Ripon as follows:

Section 2: All ordinances or parts of ordinances in conflict herewith are hereby expressly repealed.
